

## FAQs for CDC/CCC Bursary and MOE Bursary - Full-Time Singapore Citizen Undergraduate Students

### CDC/CCC BURSARY AND MOE BURSARY

#### 1) Who can apply for the CDC/CCC Bursary and MOE Bursary?

The CDC/CCC Bursary and MOE Bursary are open to subsidised Singapore Citizens pursuing MOE-subsidised full-time undergraduate programmes at Singapore University of Social Sciences (SUSS).

### Eligibility Criteria

#### 2) What are the eligibility criteria for the CDC/CCC Bursary and MOE Bursary?

There are four tiers of eligibility:

<b>Quantum (Per Academic Year)</b>	S\$4,000 per award	S\$3,750 per award	S\$2,700 per award	S\$1,350 per award

- PCI refers to gross monthly household Per Capita Income (PCI) and is computed based on GHI divided by the number of immediate and non-immediate family members living in the same household.
- GHI refers to gross monthly household income of immediate and non-immediate family members, where:

*For Unmarried Students:*

- (1) Immediate family members include parents who may or may not be living together with the student
- (2) Non-immediate family members include grandparents, siblings, spouses of siblings, siblings of parents, and any other relatives living together with the student.

*For Married Students:*

- (1) Immediate family members include spouse and all children who may or may not be living together with the student
- (2) Non-immediate family members include parents, grandparents, siblings, spouses of siblings, siblings of parents, and any other relatives living together with the student.

**Application Process**

**3) When and how can I apply for the CDC/CCC Bursary and MOE Bursary? When will I be notified of the application outcome? When can I expect to receive the Bursary amount?**

You may apply for the CDC/CCC Bursary and MOE Bursary in the academic year that you are in need, subject to the condition that you must be pursuing *at least one new or repeat course* for the academic year in which the bursary is awarded. Students who are on deferment will not be eligible to apply for the CDC/CCC Bursary and MOE Bursary.

The application periods, notification and disbursement dates are as follows:

Application Period	Notification Date	Disbursement Date
1 June to 15 July	End August	End September-October

Only successful applicants will be notified via their MyMail email account. MOE Bursary recipients will receive the bursary payment via GIRO from SUSS according to the above disbursement date while CDC/CCC Bursary recipients will receive the disbursement details from their respective Community Clubs (CCs) nearest to their home.

**4) What are the supporting documents that I have to submit with the CDC/CCC Bursary and MOE Bursary application? How and when can I submit them? If I missed out submitting the supporting documents, what happens to my application?**

You are required to submit your supporting documents (click [here](#)) online together with your CDC/CCC Bursary and MOE Bursary e-application. Applications without full set of supporting documents will be deemed as incomplete and will not be processed.

**5) If I miss the application deadline, can I still submit my application?**

You should submit the CDC/CCC Bursary and MOE Bursary application during the specified application periods. If you are in need of financial assistance outside the application periods, you may write to SUSS, quoting reason(s) for your late application and providing documents to support your application. The University will consider your application on a case-by-case basis. You will receive your application outcome within four weeks from the date you submit your application with the full set of supporting documents.

**6) What is the CDC/CCC Bursary and MOE Bursary amount that I can expect to receive?**

The value of your bursary depends on your household per capita income. Please refer to the table under Q2 for the amount. In the event that your GHI and PCI are pegged to different bursary tiers, the bursary that accords the higher provision will be awarded to you.

**7) If I am currently a CDC/CCC Bursary or MOE Bursary recipient, will I automatically be awarded the bursary again for the next academic year?**

No, each award is tenable for one academic year. You have to file another CDC/CCC Bursary and MOE Bursary application should you wish to be considered for the bursary in the next academic year.

**8) How many times can I be awarded the CDC/CCC Bursary or MOE Bursary?**

You may apply for the CDC/CCC Bursary and MOE Bursary in any academic year(s) that you are experiencing financial need. You can receive a maximum of one (1) CDC/CCC Bursary or MOE Bursary each academic year.

**9) Do I have to repay the CDC/CCC Bursary or MOE Bursary awarded to me?**

The CDC/CCC Bursary and MOE Bursary are free financial aid that does not require any repayment. However, you will have to refund the bursary received if you withdraw from the programme or fail to start your intended new or repeat course(s) in the academic year in which the bursary is awarded.

**10) If I am not successful in the CDC/CCC Bursary and MOE Bursary application, can I apply for it again?**

Yes, you can apply for the CDC/CCC Bursary and MOE Bursary again. Each application will be processed based on the applicant's latest financial situation. Granting of the CDC/CCC Bursary or MOE Bursary will be subject to the eligibility criteria.

**11) Can I hold more than one bursary, scholarship or a combination of bursaries and scholarships concurrently?**

In general, students receiving the CDC/CCC Bursary or MOE Bursary must not concurrently hold other bursaries or scholarships. However, students who are awarded scholarships/sponsorships/study grants, which are meant to cover the tuition fee only, can concurrently hold the CDC/CCC Bursary or MOE Bursary.

**12) Is there a cap to the number of CDC/CCC Bursary or MOE Bursary that will be given out to SUSS students in each academic year?**

There is no cap on the number of CDC/CCC Bursary or MOE bursary to be given out to the students each academic year.

**13) If I failed to deposit the CDC/CCC Bursary cheque within the validity period, can I request for a replacement cheque?**

If you had been unable to deposit the cheque within the validity period (six months from the date of issuance as indicated on the cheque) for valid reasons and your cheque has expired, you can approach Student Support Department to explain your situation and request for the CDC/CCC Bursary award to be re-issued to you, as well as return the expired cheque to the institution. However, please note that you must do so within one year from the date of bursary cheque issuance. Any request to claim the bursary monies for cheques which have expired beyond one year after cheque issuance date will be rejected.
